Dear Student,

The ladies of the Henrico County Alumnae Chapter of Delta Sigma Theta Sorority, Inc. (HCAC) will be awarding one \$1000 and two \$500 scholarships to graduating high school senior students from Northeastern Henrico, New Kent and Charles City Counties who exemplify excellence in community service and overall outstanding academic achievement. Delta Sigma Theta Sorority, Inc. is a private, non-profit organization whose purpose is to provide assistance and support through established programs in local communities throughout the world. The Henrico County Alumnae Chapter was established in 2000 and is dedicated to public service, scholarship, and educational excellence.

In order to be eligible for this scholarship, you must meet the following criteria:

- (1) **Reside or attend school** in HCAC's service area. Our service area is East of Interstate 95 **including** Henrico County, Charles City, and New Kent, **excluding** the City of Richmond and Hanover County.
- (2) Have a minimum cumulative GPA of 2.5 calculated through January 31, 2010.
- (3) Provide a copy of official transcript in a sealed envelope.
- (4) Submit a typed essay not to exceed two pages on the topic below:

*The Henrico County Alumnae Chapter is beginning an initiative to increase the amount of registered organ donors.*

*How do you propose that we educate the community about the importance of organ donation?*

- (5) Submit a personal statement that includes an overall synopsis of your leadership abilities, community service, career goals, aspirations and areas of interest. Maximum of two typewritten pages double spaced.
- (6) Submit two letters of recommendation with at least one referencing some form of community service from a school official, extracurricular activity sponsor, a church official, or community leader. Letters must be on official letterhead, typewritten, signed, and placed in a sealed envelope; persons writing references cannot be related to applicant by birth or marriage.
- (7) Submit a completed application.

Follow instructions carefully. Incomplete applications **WILL NOT** be considered. Application and supporting materials must be **received by March 12, 2010** to the following address:

The final selection of scholarship recipients will be based upon cumulative grade point average, school/community involvement, recommendations, personal statement, and essay. Recipients will be notified by **April 9, 2010** and expected to attend our Annual May Week Scholarship Program (further notice will be provided at a later date). All awards will be submitted directly to the college/university once proof of enrollment is received. Winners will be expected to submit proof of enrollment in a college/university no later than October 1, 2010.
